Depart: Loriella Park at 4:00am from the Pool Parking Lot

Arrive: New York City at approximately 10:00am at Macy's on 34th Street

Depart: New York City at 6:30pm from Macy's on 34th Street

Arrive: Loriella Park at approximately 1:30am



Buses will stop once around the halfway point going to the city, and once around the halfway point on the way back.

Once in New York you can tour the city by taxi, bus, foot or subway, shop, see a play, or visit museums. If you plan to see a Broadway Play, you will be responsible for purchasing your own tickets. Please make sure the show time fits within the arrival and departure time of the bus.

Dress appropriately for the weather and wear comfortable walking shoes.

Birth Certificate required at the time of registration, if one is not already on file with the Department, for everyone under the age of 18. Make checks payable to: "**Treasurer, Spotsylvania County.**" *There is a \$50.00 fee for returned checks.* There will be an additional charge of \$10.00 on all late registrations, if space permits. **2.95% NON-REFUNDABLE CONVENIENCE FEE CHARGED ON ALL CREDIT/DEBIT CARD TRANSACTIONS.**

TO REGISTER ONLINE: A Household waiver needs to be completed and on file at the Parks and Recreation office prior to registering online. Visit www.spotsylvania.va.us/parksandrec.

PRE-REGISTRATION IS REQUIRED. Spotsylvania Parks & Recreation reserves the right to cancel trip if registration is not sufficient.

WITHDRAWALS: Those wishing to withdraw from the trip must do so by contacting the Spotsylvania Parks and Recreation Department by the registration deadline. Individuals should follow up their verbal cancellation request with a written refund request. A 20% administrative fee will be charged on all refunds. There will be no refunds given to those who withdraw from the trip after the registration deadline.
