Promotional banners can be displayed on the outfield fences for the duration of the season, March through November, or for a shorter time period. Rules and Regulations

- Banners/Signs shall be 3ft x 6ft for display on a 10 oz. Nylon Mesh material with grommets for attachment.
- Banners/Signs will be placed on appropriate fence structures for visibility of park visitors. Installation will be the responsibility of the Parks and Recreation Department.
- Banners/Signs will be reviewed by Parks and Recreation staff for appropriateness before being constructed.
- Banners/Signs shall not consist of information concerning the following: Promoting hostility, disorder, violence or attacks on any person or group of persons; Promoting discrimination including but not limited to, demeaning, harassing, or ridiculing any person or group based on race, color, nationality, religion, sex, age, disability, ancestry or creed; Libelous statements for information; Promoting, favoring, or opposing the candidacy of any candidate for election or public question; Being obscene or pornographic as defined by the prevailing community; Promoting the use of alcohol, tobacco, firearms or weapons of any kind.
- Banners/Signs will be constructed at the cost of the advertiser once the template has been approved by the Parks and Recreation Department. The banner will remain the property of the advertiser.
- Banners/Signs will be displayed from March-July, July-November, or March-November at the approved location.
- Spotsylvania County Parks and Recreation is not responsible for any damage to banners/signs due to weather, graffiti, and/or vandalism of any kind. If the banner/sign is destroyed, the advertiser will be responsible for replacement.
