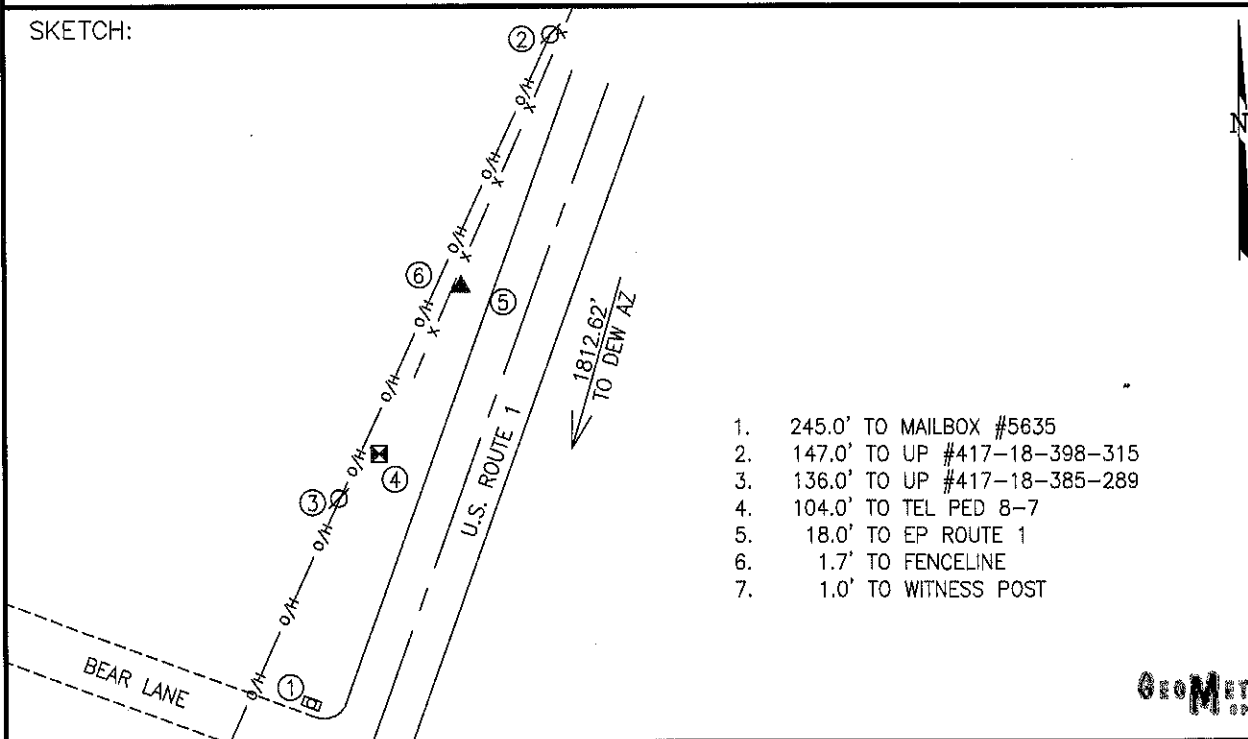
THE STATION IS LOCATED IN SPOTSYLVANIA COUNTY, VIRGINIA, APPROXIMATELY 21.7 KM (13.5 MILES) SOUTH OF THE CITY OF FREDERICKSBURG AND 11.3 KM (7.0 MILES) SOUTHEAST OF THE SPOTSYLVANIA COURTHOUSE.

TO REACH THE STATION FROM THE INTERSECTION OF US HIGHWAY 1 (JEFFERSON DAVIS HIGHWAY) AND STATE ROUTE 603 (ARCADIA ROAD), GO NORTH ON US HIGHWAY 1 FOR 0.6 KM (0.4 MILE) TO THE STATION ON THE LEFT.

STATION DEW AZ IS INTERVISIBLE WITH STATION DEW.

THE STATION IS A 3 1/2 INCH SPOTSYLVANIA COUNTY, VA ALUMINUM SURVEY DISK SET INTO A POURED IN PLACE CONCRETE MONUMENT 10 INCHES IN DIAMETER, FLUSH WITH THE GROUND SURFACE AND STAMPED DEW AZ 2004.
